Conditions of Use Agreement
Park Pavilions and Field Rentals

We are pleased that you have chosen one of Layton City's parks for you function. As well as being some of the most beautiful in the state, our parks offer many amenities as well. Because of their popularity, thousands of people utilize them throughout the season. In order to preserve the beauty of the parks as well as the pavilions and playgrounds, we have listed some of the conditions of use below. Please read them carefully as you will be asked to acknowledge that you have read and understand them.

- ❖ No vehicles on the grass or sidewalks at any time. City Ordinance No. 10.96.02
- ❖ No alcoholic beverages in the parks. City Ordinance No. 9.20.10
- ❖ No dogs allowed in the parks. City Ordinance No. 8.07.06
- ❖ Indemnification: We the undersigned, in exchange of good and valuable consideration, receipt of which is hereby acknowledged, including the use of the Layton City park, pavilion or field, do hereby indemnify Layton City, its officers, employees, agents, volunteers, officials, against any claim of any kind relating to any and all equipment and toys brought to the Park for the undersigned's use while in the Park. The undersigned will limit the use of the equipment and toys to those invited and authorized by the undersigned to participate in these activities.
- ❖ Cookers, BBQ's, Dutch Ovens or sno-cone machines, etc. must be used on concrete surfaces. All coals, oils and grease should be cleaned up.
- ❖ Do not dump anything on the lawn that will harm the grass, examples: cooking oil, coals, salt, hot water, etc.
- ❖ Picnic tables are to remain in place. There will be an additional charge if you need the tables moved. Please contact us 72 hours prior to reservation to make payment and arrange for the tables being moved.
- ❖ Drink vehicles or trailers must remain on the pavement
- ❖ No air structures (bounce houses) in the park without an approved Special Event application and the required liability insurance.
- ❖ Do not put nails in any of the pavilion walls. Remove all masking tape from the tables and walls.
- ❖ Clean up all trash and remove it from the Park. Bring extra trash bags to clean up the area.
- ❖ All Layton City facilities are smoke free as per state law.

Failure to comply with the above conditions of use will result in the forfeiture of your deposit and could include additional costs.

Reservation names and reservation times will be posted at the designated field or pavilion; however, keep your rental receipt with you during the rental. **Your rental reserves the entire pavilion or designated park area for your use.** If you have any problems with another party please contact the on-call parks employee by calling 801-336-3911. If you cannot get hold of a parks employee please contact the police dispatch at 801-497-8300.
